1. Information on how to enter and prizes form part of these Terms & Conditions. Participation in this Endeavour Hills Shopping Centre's Mother's Day: Win a \$2,000 Shopping Spree for Mum ("Promotion") is deemed acceptance of these Terms & Conditions.
2. This Promotion is only available at Endeavour Hills Shopping Centre, Matthew Flinders Ave, Endeavour Hills VIC 3802.

ELIGIBILITY

3. Subject to condition 4, this Promotion is open to all Endeavour Hills Shopping Centre shoppers. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all Terms & Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. The following are ineligible:
 - a. Endeavour Hills Shopping Centre staff, contractors, agents, and their immediate families
 - b. Centre tenants, their staff, contractors and immediate families
 - c. Individuals involved in the Promotion's production, publishing, or administration, and their immediate families
 - d. Previously excluded persons

Immediate family includes spouse, de facto spouse, parents, children, siblings and grandparents. Tenants refer to lessees, licensees, and corporate directors.

PROMOTION PERIOD

5. The Promotion is only open from Monday 4 May 2026 to Friday 8 May 2026, Australian Eastern Standard Time ("AEST") during Endeavour Hills Shopping Centre Trading Hours ("Promotion Period").
6. Entries within the Promotion Period is open from 9am – 4pm from Monday 4 May – Friday 8 May 2026.
7. The Promotion Period is subject to change without notice.

HOW TO ENTER

8. To enter this Promotion, eligible individuals must make a minimum spend of \$80 (“Qualifying Spend”), at any specialty store, OR \$120 at any major store (list of participating specialty and major stores can be viewed at the bottom of this document) in one transaction.
9. Customers must then visit the Centre Management Office with their receipt to enter their details and go into the draw.
10. By providing your email, you will be signed up to the Endeavour Hills Shopping Centre mailing list.
11. Receipts must be an official receipt with ‘TAX INVOICE’ clearly stated.

LIMITS OF ENTRY

12. Multiple entries are permitted, providing that a new spend/receipt is provided.
13. Repeat entries with the same receipt will be discarded.
14. The Qualifying Spend must be made in one transaction. Multiple receipts to make up the Qualifying Spend will not be accepted.
15. The spend must be made within the Promotion Period.
16. Layby purchases (unless they are final payments), ATM withdrawals, and credit card receipts are not considered valid receipts.
17. Incomplete, indecipherable or illegible entries will be deemed invalid.

WINNER ANNOUNCEMENT

18. One Winner will be drawn at random and announced after 4pm, Friday 8 May 2026.
19. The Winner will be contacted via phone call.
20. Once announced, the Winner can arrange a suitable time to collect their Prize within business hours of Endeavour Hills Shopping Centre.
21. The Prize must be collected from the Endeavour Hills Shopping Centre, Centre Management Office.
22. The Winner must bring a form of ID to collect their Prize.
23. If the Winner cannot visit Endeavour Hills Shopping Centre, they may opt for a Proxy. Details of the proxy must be provided to the Centre Management Office by calling 03 9700 2374. The Proxy will be required to bring a form of ID to collect the Prize.
24. The Prize will not be mailed or sent to the Winner. The prize can be collected only

from the Endeavour Hills Shopping Centre, Centre Management Office.

Prize

25. The Prize is a \$2,000 Endeavour Hills Shopping Centre Gift Card.
26. There is one Prize to be won, valued at a total of \$2,002.95 which includes a \$2.95 Gift Card activation fee.

GENERAL

28. The Promotion is promoted by Endeavour Hills Shopping Centre Pty Ltd ABN 61 113 715 923 ("Promoter"), of Endeavour Hills Shopping Centre, Matthew Flinders Ave, Endeavour Hills VIC 3802.
29. By entering the Promotion, each Entrant grants to the Promoter and the Centre Management at Endeavour Hills Shopping Centre (Centre Management), perpetual, irrevocable, non-exclusive, transferable, royalty free and sub-licensable right and license to use reproduce, modify, adapt, publish or display (in whole or in part) any intellectual property contained in the content of their Entry and/or Photo, without royalty, payment or other compensation. 52. The terms and conditions of the Promotion do not intend to conflict with, or derogate from, a Provider's terms and conditions of use, statement of rights and responsibilities (if any), data use policy or any other terms and conditions imposed by the relevant Provider on Entrants from time to time to use the relevant social media platform.
