### **'MOTHERS DAY' PROMOTION**

#### **Terms and Conditions**

##### **Promotional Period**

The PROMOTION opens at 11am, Tuesday 4<sup>th</sup> May and closes at 3pm, Saturday 8<sup>th</sup> May 2021 or when all 600 assorted Plaques ("gift") are distributed by the Promoter, whichever comes first.

##### **How to enter**

To enter the Endeavour Hills Shopping Centre 'Mothers Day' Promotion, customers must do the following during the Promotional Period:

1. Make a purchase of \$25 or more at any participating store within Endeavour Hills Shopping Centre during the promotional period. Participating stores include all retailers in Endeavour Hills Shopping Centre, excluding Major stores Aldi, Coles, Dan Murphys, Kmart, Liquorland and Woolworths.
2. Visit the host between 11am and 3pm, from Tuesday to Saturday, or alternatively go to Centre Management in business hours, during the Promotional Period.
3. Present your receipt of \$25 or more to the host to receive a gift.

##### **Conditions of entry**
